

# KEY INVESTOR INFORMATION

This document provides you with key investor information about this sub-fund. It is not marketing material. The information is required by law to help you understand the nature and the risks of investing in this sub-fund. You are advised to read it so you can make an informed decision about whether to invest.



## New Mountain Vantage UCITS Fund a Sub-Fund of MontLake UCITS Platform ICAV, managed by MLC Management Limited EUR Institutional Class Founder Shares (IE00BXC45506)

### Objectives and Investment Policy

The investment objective of the Sub-Fund is to seek capital appreciation over the medium to long term.

The Sub-Fund will primarily invest in (both long and short) U.S. equities and equity related securities companies, collective investment schemes ("CIS") and exchange traded funds ("ETF"). While noting that the principal focus of the Sub-Fund is on the U.S., the Sub-Fund may also invest to a limited extent in shares of non-U.S. companies. The Sub-Fund will seek to invest based on fundamental research in high quality companies whose securities are substantially undervalued relative to the intrinsic value and where there are opportunities for price appreciation.

The Sub-Fund will gain short exposure to companies whose share price appears to be overvalued based on the research carried out. The Sub-Fund will sell shares in the companies with the expectation that the share can be purchased at a lower price in the future.

The Sub-Fund is not subject to any specific industry sector constraints on target investments but will generally focus on certain industries such as healthcare (i.e. specialty pharma, hospitals), business services (i.e. payroll services, benefits services and information services), the technology sector (i.e. payment processors, software), media (paid television operators, cable networks) and the energy sector (typically energy services related companies).

The Sub-Fund may use swaps, futures and contracts for difference to gain both long and short exposure. The Sub-Fund may also utilise

forward contracts for currency hedging purposes.

The Sub-Fund may also gain exposure through the use of derivatives (as described above) and ETFs to U.S. interest rates and commodities for hedging purposes only. The Sub-Fund may also gain exposure through the use of derivatives (as described above) to the CBOE Volatility Index for hedging purposes only.

It is expected that by using derivatives, the Sub-Fund's long positions will be approximately 70% to 100% of the net asset value of the Sub-Fund and short positions between 0% and 60%, and, when netted off against each other, the Sub-Fund may be up to 100% long or short at any given time.

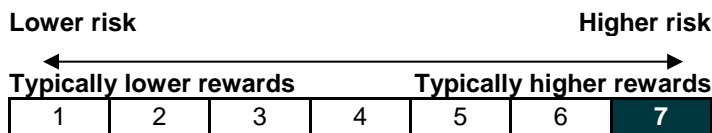
You can sell your shares on any day that banks are open in Ireland and United States. You must submit your application to the Sub-Fund's Administrator before 1.00 p.m. one business day before the day on which you want to sell.

Your shares do not pay you income, but instead the Sub-Fund reinvests any income to grow your capital.

As your shares are denominated in Euro and the Sub-Fund is in U.S. Dollars, forward contracts are used to attempt to eliminate the effects of changes in the currency exchange rates against U.S. Dollars.

Recommendation: the Sub-Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

### Risk and Reward Profile



The risk category for this Sub-Fund is set at 7. It is calculated in line with EU regulations and is based on the risk limit for the Sub-Fund. A **category 1** Sub-Fund is not a risk-free investment - the risk of losing your money is small, but the chance of making gains is also limited. With a **category 7** Sub-Fund, the risk of losing your money is high but there is also a chance of making higher gains. The seven-category scale is complex. For example, a category 2 Sub-Fund is not twice as risky as a category 1 Sub-Fund. The risk category shown is not guaranteed and may change over time.

When categorising the Sub-Fund it may happen that not all material risks were fully captured in the methodology. For a more detailed explanation of risks, please refer to the "Special Considerations and Risk Factors" section of the prospectus.

**Liquidity Risk:** Securities in which the Sub-Fund invests may be sold below their intrinsic valuation due to insufficient liquidity in the market.

**Counterparty Risk:** A counterparty may fail in paying the proceeds of sale for assets sold by the Sub-Fund and/or may fail in delivering securities purchased by the Sub-Fund.

**Derivatives and Leverage Risk:** The Sub-Fund may use financial derivative instruments for taking short positions or for other investment or hedging purposes. Whilst this is intended to help the Sub-Fund to manage risk or to take investment positions more efficiently or effectively than could be done otherwise, leverage and shorting can involve the risk of higher volatility, especially if some of

the expected offsetting positions between long and short investments do not work as expected, and the Sub-Fund may be exposed to additional risks and costs as a result.

**Short Selling Risk:** The Sub-Fund may create synthetic short positions through the use of derivatives. Short positions behave differently to long positions; for example, the Sub-Fund can come under pressure to close out short positions at short notice and before an offsetting long position can mature. This can create unexpected losses from positions that might otherwise have been seen as low risk or well hedged.

## Charges

The charges you pay are used to pay the costs of running the Sub-Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

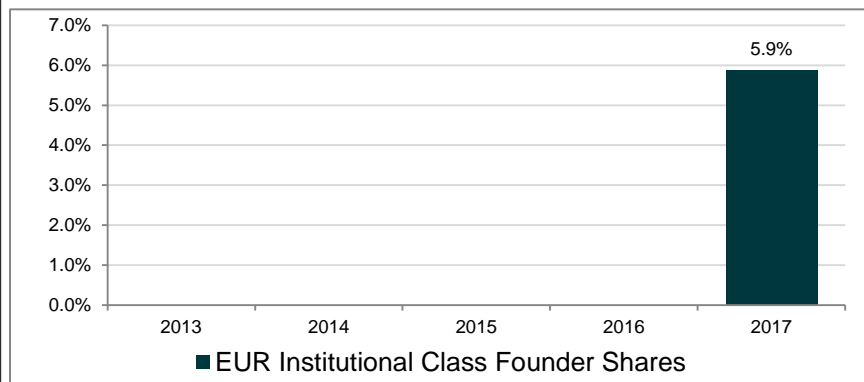

You may switch your shares to the shares of another Sub-Fund of MontLake UCITS Platform ICAV free of charge.
